**Call to Order**

Mr. Travis Tharp called the meeting to order at 9:12am.

Mr. Odom made a motion to appoint Mr. Foreman to District 5, seconded by Mrs. Taylor. Motion carried unopposed.

Mr. Foreman doesn't reside in District 5, however according to the Department of Agriculture Guidance provided at the last Area AFCD meeting, and to the best of the Board's knowledge, he is allowed to be appointed to it.

Mr. Odom stated once all vacancies have been filled, the Board will have an election of officers.

Mr. Tharp discussed the need for the Board to come together with their roles and responsibilities especially in conducting outreach activities.

Mrs. Taylor she would like to attend the upcoming AFCD annual meeting being held September 26, 2023 - September 27, 2023 in Gainesville, FL.


Mrs. Taylor made a motion to be the designated representative for the ESWCD, seconded by Mr. Odom. Motion carried unopposed.
